



PARTICIPATION AGREEMENT

To submit your film (Film) to Little Big Shots 2012 (Festival), which is run by Petite Grand Kaboom Ltd. (T/A Little Big Shots International Film Festival for Kids) (ABN 49 132 811 619), you (Filmmaker) must agree to the following:

1. All the information entered in the Little Big Shots 2012 online entry form is true and accurate.
2. You either own the rights to, or have permission to use, the footage, sound, music, images and all other contributions that are part of the Film to the extent necessary to submit the Film to the Festival. Please note: if you have any doubts about any of the rights in the Film, you must notify the Festival at the time of submission.
3. Completing the online entry form and this Participation Agreement does not guarantee acceptance into the Festival. If unsuccessful, due to the high volume of entries we receive, your preview DVD and other submission materials will not be returned to you.

If your film is selected to screen as part of Little Big Shots 2012:

1. You grant the Festival a gratis, non-exclusive worldwide licence to screen the Film as part of all Festival screenings between June 2012 and June 2013. An updated list of screening venues and events can be found on the Little Big Shots website (www.littlebigshots.com.au).
2. You will provide the Festival with a screening version of the Film by no later than March 01, 2012 (film prints for Melbourne to arrive by May 03, 2012).
3. The Festival will prepare professional session compiles at its own cost for screening at all its venues. The screening version of the Film will be returned after June 2012 to the address you supplied in the online entry form. The Festival will retain a copy of the Film as part of its master compile for archival purposes.
4. You must notify the Festival immediately if any of the rights in the Film become disputed.
5. You must indemnify the Festival from all claims made against the Festival arising from or in connection with the submission of the Film, or any infringement of any intellectual property in connection with the screening of the Film as part of the Festival.
6. You grant the Festival a gratis, non-exclusive worldwide licence to use film excerpts, film stills, press kits and other promotional materials from the Film for publicity and promotional purposes in relation to the Festival, including on its website (www.littlebigshots.com.au), for a period of three years from the date of this agreement. The Festival will not use your promotional materials for any third party endorsement or commercial activities without your prior written consent.
